Data Analysis

We are working on Student Learning Objects (SLO) for the 2014 teacher evaluation performance scores. We are working on the 2012-2014 IB and AICE analysis.

Mobile Learning is working hard to catch up on the work requests. Thank you for your patience during this unprecedented work load.

Data Processing

This past week Data Processing completed submission of Survey 6 and Survey 8. Survey 6 provides an initial enrollment count to DOE for projection purposes, and Survey 8 is used to roster the PMRN for schools that use the FAIR and the FLKRS test for kindergarten students. We have begun working with the office of Teacher Evaluation to review/finalize the 2014 evaluation cycle using state VAM data. We have also completed the first submission of seniors' transcripts to Bright Futures for early evaluation. We are working with schools to correct transcript and schedule errors that are indicated by FASTER for resubmission. We have also completed a full upload of staff files in compliance with single sign-on expectations from DOE and authorized district level users for IBTP. Look for graduation rate information coming soon to a high school near you.
